## Wildlife Freedom, Inc.

It's about that time of the year; as the snow melts and the days get longer, we will begin seeing more wildlife activity. Spring means "new life - new beginnings." This applies to our animal kingdom as well. It's the time of year when the wildlife begins looking for that "perfect" place to give birth to their young. Your home and property may just be the ideal place. There are many things you can be forewarned about. Noises in your attic, which was quiet all winter, broken attic vents, new areas on your property being dug up, even noises in your fireplace, or torn rotted boards in your eaves all may be signs you have an intruder out and about. If you truly feel you may have an intruder in or around your premises, don't become too alarmed. Any situation or problem can be solved in a reasonable and professional manner. Never - under any circumstance contact the first pest control company in your phone book. The majority of them are not trained correctly to even know when young are actually born. They can and do use costly methods and even scare tactics by frightening the homeowner with false information. Many, many times they remove the adult intruder, thus leaving the tiny infants behind to suffer and die. If they are newborn, they certainly cannot *leave* on their own.

If you do have a potential problem, first call your local animal control officer and/or police department. Hopefully they can direct you to a knowledgeable wildlife removal service or directly to me. I only work with a few pest control agencies who I know are reliable, honest, humane and less costly than most. Of course, some issues can be very easily solved over the phone costing the homeowner nothing! One



way or another, I would always be available to assist you with whatever problem you may have in a professional and less expensive manner that would benefit you and your wildlife intruder. ## Olive Oil in Tuscany: Stay, Learn, Taste *submitted by Carolyn Masone*

Taste of Italy

During the last week of November, workers in the chilly Tuscan air will be leaning on ladders propped against 4,000 olive trees. Picking each olive by hand and tossing them into baskets, they will carry out the centuries-old *brucatura* method of olive harvesting. Such is life at the vineyard Podere Pornanino in the central Tuscan town of Radda in Chianti.

I had the pleasure of meeting Francesco and Lia Lombardi, along with their daughter and son-in-law, who introduced me to their family business and the center of their lives: olive oil production at Podere Pornanino. There are four varieties of olive trees on the estate: Frantoio, Pendolino, Moraiolo and Leccino, which



together create the distinctive flavor of Pornanino Extra Virgin Olive Oil. Francesco, Lia and family personally bottle the oil on site.

Originally from Milan, Francesco Lombardi bought Pornanino in 1989 as a tranquil place for both of them to retire. They looked forward to nurturing their small number of fruit trees and prolific vegetable garden in the Chianti hills. Set between the towns of Radda, Castellina and Bagliagli, they chose a property bordered by two rivers with views that go on forever. All seemed complete and blissfully uneventful. Until one day when Francesco discovered that his property included an abandoned olive grove of about 500 trees. Intrigued, he brought the orchard back to life and harvested the olives. After a visit to the public olive press, he enjoyed Pornanino's first Extra Virgin Olive Oil.

This experience inspired Francesco and Lia to launch a new phase in their lives. They planted another 3,500 olive trees and purchased a renovated stone wheel press. They renovated the barn and placed the press inside. At harvest time, the mill slowly crushes the olives, bringing out their fragrance and sweetness. Pornanino is one of only 14 companies in all of Tuscany that still uses a stone mill. The extra virgin olive oil is extracted from the resulting paste by applying high pressure rather than heat. This heat-free method allows the oil to retain its prized sensory and nutritional characteristics. This process is slower than more modern methods, but the resulting flavor is worth the wait. The enterprise increased and, six years ago, their daughter Francesca and her husband Matteo joined the family at Pornanino.

They have also created line of soap bars made with extra virgin olive oil. This lightly fragranced soap lathers well and is a treatment for the skin.

In addition to the olive groves and woodlands on the estate, the family restored other farm structures and created beautiful villa apartments for tourist holidays. Every Tuesday morning, Francesco gives a popular seminar for his guests on the production and intricacies of olive oil. Along with a tasting, of course!







### PASTA MELANZANE - A Healthy Recipe

- 2/3 LB. Eggplant
- 1 Can Stewed Tomatoes
- 2-3 Cups Spaghetti Sauce
- 1/2 LB. Fresh Mushrooms or more

#### Choice of Pasta

If you have the long skinny type of eggplants, cut them in thin rounds. For the egg-shaped version, cut in quarters lengthwise and then slice thinly. Place in a large pot with the tomatoes (broken up) and spaghetti sauce, and start to simmer.



Meanwhile, wash and slice the mushrooms, and add them to the pot. The eggplant needs to be cooked until it changes to a slightly darker color and is quite soft. If the slices are thin, this might take about an hour. If you have vegetable-suspicious people in the family, you can cook the sauce for even longer, until the eggplant disintegrates into the sauce.


## Why We Say...

**Olive Oil and Heart Disease.** Studies have shown that people who consumed about 2 tablespoons of virgin olive oil daily for one week showed less oxidation of LDL cholesterol and higher levels of antioxidant compounds, particularly phenols, in the blood. But while all types of olive oil are sources of monounsaturated fat, Extra Virgin Olive Oil, from the first pressing of the olives, contains higher levels of antioxidants, particularly vitamin E and phenols, because it is less processed.



Olive oil is clearly one of the good oils, one of the healing fats. Most people do quite well with it since it does not upset the critical omega 6 to omega 3 ration and most of the fatty acids in olive oil are actually an omega-9 oil, which is monounsaturated.

**Posting Signs and Banners on Utility Poles**

NJSA 27:5-9 prohibits the placing of signs (political or otherwise) on public utility poles. *A sign may not be painted, drawn, erected or maintained upon trees, rocks, other natural features or public utility poles.*

NJSA 27:5-23: *It shall be the duty of all departments of State or local government...to assist in the enforcement of the provisions of this act...and the Chief of Police of any municipality is authorized and charged under the direction of the commissioner to enforce these provisions.*


**Section 27:5-16 prescribes penalties ranging from \$50 to \$500 for each offense. Each day of the violation may be deemed a separate offense.**

**These signs pose a safety hazard to utility workers. Not only do the signs often prevent them from being able to physically climb the pole; but nails, staples, etc. could cause injury to utility workers or could jeopardize the integrity of safety equipment (gloves) that may be punctured.**

The Riverdale Water Department is located at the DPW Building on Dalton Drive, and the administrative offices are located in the Borough Hall at 91 Newark Pompton Turnpike. Questions concerning this report should be directed to Mr. Walter Mahon, DPW Superintendent, at (973) 835-6077. The Borough Council holds regular public meetings every first and third Monday of the month at 7:30 P.M., at the Borough Hall. Included in this report are details about where your water comes from, what it contains, and how it compares to Environmental Protection Agency (EPA) and State standards. As always, we are committed to providing you with the highest quality drinking water and service. Please do not hesitate to contact us at any time.

Some people may be more vulnerable to contaminants in drinking water than the general population. Immuno-compromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly, and infants can be particularly at risk from infections. These people should seek advice about drinking water from their health care providers. EPA/CDC guidelines on appropriate means to lessen the risk of infection by *Cryptosporidium* and other microbial contaminants are available from the Safe Drinking Water Hotline 1-(800) 426-4791.

Water for the Riverdale system is derived from a production well located on Dalton Drive. The Borough also purchases water from the Passaic Valley Water Commission (PVWC). Approximately 75% of the total water used by the homes and businesses in Riverdale is derived from the Borough's well. A copy of the Consumer Confidence Report from PVWC is appended to this report.

**Source Water Assessments:** The New Jersey Department of Environmental Protection (NJDEP) has completed and issued the Source Water Assessment Report and Summary for the Riverdale water system, which is available at [www.state.nj.us/dep/swap](http://www.state.nj.us/dep/swap) or by contacting NJDEP's Bureau of Safe Drinking Water at (609) 292-5550. Riverdale monitors its water sources for

regulated contaminants in accordance with NJDEP requirements. Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water poses a health risk. More information about contaminants and potential health effects can be obtained by calling the EPA's Safe Drinking Water Hotline 1-(800) 426-4791.

The sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs, and wells. As water travels over the surface of the land or through the ground, it dissolves naturally occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activity.

Contaminants that may be present in source water before we treat it include: *Microbial contaminants*, such as viruses and bacteria, which may come from sewage treatment plants, septic systems, agricultural livestock operations, and wild life.

*Inorganic contaminants*, such as salts and metals, which can be naturally occurring or result from urban stormwater runoff, industrial or domestic wastewater discharges, oil and gas production, mining or farming. *Pesticides and herbicides*, which may come from a variety of sources such as agriculture and residential uses.

*Radioactive contaminants*, which are naturally occurring. *Organic chemical contaminants*, including synthetic and volatile organic chemicals, which are by-products of industrial processes and petroleum production, and also come from gas stations, urban stormwater runoff, and septic systems.

**In order to ensure that tap water is safe to drink**, EPA prescribes regulations which limit the amount of certain contaminants in water provided by public water systems. We treat our water according to EPA's regulations. Food and Drug Administrations (FDA) establish limits of contaminants in bottled water, which must provide the same protection for public health.

## WATER QUALITY DATA

The table below lists all the drinking water contaminants that we detected during the 2010 calendar year. The presence of these contaminants in the water does not necessarily indicate that the water poses a health risk. Unless otherwise noted, the data presented in this table is from testing performed between January 1, 2010 and December 31, 2010. The State of New Jersey requires us to monitor for certain contaminants less than once per year because the concentrations of these contaminants are not expected to vary significantly from year to year. Therefore, some of the data, though representative of the water quality, is more than one year old.

### Terms & abbreviations used below:

**Maximum Contaminant Level (MCL):** the highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.  
**Maximum Contaminant Level Goal (MCLG):** the level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.  
**Maximum Residual Disinfectant Level (MRDL):** the highest level of a disinfectant allowed in drinking water. There is convincing evidence that addition of a disinfectant is necessary for control of microbial contaminants.  
**Maximum Residual Disinfectant Level Goal (MRDLG):** the level of a disinfectant below which there is no known or expected risk to health. MRDLGs do not reflect the benefits of the use of disinfectants to control microbial contaminants.  
**Recommended Upper Limit (RUL):** recommended maximum concentration of secondary contaminants. These reflect aesthetic qualities such as odor, taste or appearance. RUL's are recommendations, not mandates.  
**Primary Contaminants:** substances that are health-related. Water suppliers must meet all primary drinking water standards.  
**Secondary Contaminant:** substances that do not have an impact on health. Secondary contaminants affect aesthetic qualities such as odor, taste or appearance. Secondary standards are recommendations, not mandates.  
**Action Level (AL):** the concentration of a contaminant which, when exceeded, triggers treatment or other requirements which a water system must follow.

**Treatment Technique (TT):** a required process intended to reduce the level of a contaminant.

**Water Standards Information**

**Is your drinking water in compliance with all regulations?** The Borough of Riverdale is proud of the fact that our water complies with all drinking water standards for chemical and organic contaminants as set by the State of New Jersey and the U.S. EPA.

**Regarding New Standards for Arsenic.** Riverdale's water meets the EPA's standard of 5 parts per billion for arsenic.

**Regarding Asbestos, Nitrite and Synthetic Organic Compounds.** As permitted under the Safe Drinking Water Act, the State of New Jersey has issued waivers to the Borough of Riverdale for testing of asbestos, nitrite and synthetic organic compounds. These waivers were given after careful review of prior negative testing, and consideration of factors which indicate low susceptibility to these types of contaminants.

**Special Considerations Regarding Children, Pregnant Women, Nursing Mothers, and Others**

Children may receive a slightly higher amount of a contaminant present in the water than do adults, on a body weight basis, because they may drink a greater amount of water per pound of body weight than do adults. For this reason, reproductive or developmental effects are used for calculating a drinking water standard if these effects occur at lower levels than other health effects of concern. If there is insufficient toxicity information for a chemical (for example, lack of data on reproduction or developmental effects), an extra uncertainty factor may be incorporated into the calculation of the drinking water standard, thus making the standard more stringent, to account for additional uncertainties regarding these effects. In the cases of lead and nitrate, effects on infants and children are the health endpoints upon which the standards are based.

**Nitrate:** Nitrate in drinking water at levels above 10 ppm is a health risk for infants of less than six months of age. High nitrate levels in drinking water can cause blue baby syndrome. Nitrate levels may rise quickly for short periods of time because of rainfall or agricultural activity. If you are caring for an infant, you should ask advice from your health care provider.

**Lead:** If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. Riverdale is responsible for providing high quality drinking water, but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested. Information on lead in drinking water is available from the Safe Drinking Water Hotline or at <http://www.epa.gov/safewater/lead>.

**SOURCE WATER ASSESSMENT**

The New Jersey Department of Environmental Protection (NJDEP) has prepared Source Water Assessment reports and summaries for all public water systems. The Source Water Assessment, and related questions, for the PWVC system (PWS ID 1605002), North Jersey District Water Supply Commission (PWS ID 1613001), Jersey City MUA (PWS ID 090601) and Newark Water Department (PWS ID 0714001) can be obtained by logging onto NJDEP's source water assessment web site at <http://www.state.nj.us/dep/swap> or by contacting NJDEP's Bureau of Safe Drinking Water at 609-292-5550. If a system is rated highly susceptible for a contamination category, it does not mean a customer is - or will be - consuming contaminated water. The rating reflects the potential for contamination of source water, not the existence of contamination. Public water systems are required to monitor for regulated contaminants and to install treatment if any contaminants are detected at frequencies and concentrations above allowable levels. The source water assessments performed on the intakes for each system lists the following susceptibility ratings as indicated in Table 2. Contaminants that may be present in source water include:

Table 4 presents PWVC data collected as part of a study to determine the general occurrence of PFOA, PFOS and Perchlorate. Currently, there are no drinking water standards for these compounds. PWVC continues to participate in and support these types of regulatory and research efforts to maintain a position of leadership in cutting edge water treatment technology.

- Aluminum: Jersey City MUA was above New Jersey's Recommended Upper Limit (RUL) for Aluminum.
- Manganese: Jersey City MUA was above New Jersey's Recommended Upper Limit (RUL) for Manganese. The recommended upper limit for manganese is based on staining of laundry. Manganese is an essential nutrient, and toxicity is not expected from levels which would be encountered in drinking water.
- Sodium: PWWC was above New Jersey's Recommended Upper Limit (RUL) for Sodium. For healthy individuals, the sodium intake from water is not important, because a much greater intake of sodium takes place from salt in the diet. However, sodium levels above the recommended upper limit may be a concern to individuals on a sodium restricted diet.

Additional inorganic contaminants monitored but not detected in the plant effluent in 2010 include asbestos, antimony, arsenic, beryllium, bromate, cadmium, cyanide, fluoride, mercury, selenium, silver, ABS/LAS and thallium.

DEFINITIONS of TERMS and ACRONYMS

**AL:** Action Level, the concentration of a contaminant which, if exceeded, triggers treatment or other requirements which a water system must follow.

**CU:** Color unit.

**CCG:** Centers for Disease Control

**Disinfection By-product Precursors:** A common source is naturally occurring organic matter in surface water. Disinfection by-products are formed when the disinfectants (usually chlorine) used to kill pathogens react with dissolved organic material present in surface water.

**EPA:** Environmental Protection Agency

**Inorganic Contaminants:** Contaminants such as salts and metals, which can be naturally-occurring or result from urban stormwater runoff, industrial or domestic wastewater discharges, oil and gas production, mining or farming. These contaminants may be present in source water.

**MCL:** Maximum Contaminant Level; the highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.

**MCLG:** Maximum Contaminant Level Goal; the level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.

**Microbial Contaminants/Pathogens:** Disease-causing organisms such as bacteria and viruses, which may come from sewage treatment plants, septic systems, agricultural livestock operations and wildlife. Common sources are animal and human fecal wastes. These contaminants may be present in source water.

**MFL:** Million Fibers per liter.

**MRDL:** Maximum Residual Disinfectant Level; the highest level of a disinfectant allowed in drinking water. There is convincing evidence that addition of a disinfectant is necessary for control of microbial contaminants.

**MRDLG:** Maximum Residual Disinfectant Level Goal; the level of a drinking water disinfectant below which there is no known or expected risk to health. MRDLGs do not reflect the benefits of the use of disinfectants to control microbial contamination.

**NA:** Not applicable

**ND:** Not detected

**NJDWSC:** North Jersey District Water Supply Commission

**NTE:** Nephelometric Turbidity Unit

**Nutrients:** Compounds, minerals and elements that aid growth, that are both naturally occurring and man-made. Examples include nitrogen and phosphorus.

**Organic Contaminants/Volatile Organic Compounds:** Compounds, including synthetic and volatile organic chemicals, which are by-products of industrial processes and petroleum production, and can also come from gas stations, urban stormwater runoff, and septic systems. Man-made chemicals used as solvents, degreasers, and gasoline components. Examples include benzene, methyl tertiary butyl ether (MTBE), and vinyl chloride. These compounds may be present in source water.

**Pesticides/Herbicides:** Man-made chemicals used to control pests, weeds and fungus, which may come from a variety of sources such as agriculture, urban stormwater runoff, and residential uses and may be present in source water. Common sources include land application and manufacturing centers of pesticides. Examples include herbicides such as atrazine, and insecticides such as chlordane.

**rad:** radsources per liter (a measure of radioactivity)

**ppb:** parts per billion

**ppm:** parts per million

**PWSID:** Public Water System Identification

**PWWC:** Passaic Valley Water Commission

**RAA:** Running annual average.

**Radioactive Contaminants/Heavy Metals:** Radioactive substances that are both naturally occurring and man-made and may be present in source water, result of oil and gas production and mining activities. Examples include radium and uranium.

**Radiation:** Colorless, odorless, cancer-causing gas that occurs naturally in the environment.

**RUL:** Recommended Upper Limit, the highest level of a constituent of drinking water that is recommended in order to protect aesthetic quality.

**RUL Achieved:** Yes entry indicates the state recommended upper limit was not exceeded. A no entry indicates the state recommended upper limit was exceeded.

**TON:** threshold odor number

**T:** Treatment Technique; a required process intended to reduce the level of a contaminant in drinking water.

**% Removal Ratio:** Actual percent removal divided by required percent removal, multiplied by 100.
