ORDINANCE NO. 03-2015

ORDINANCE AMENDING CHAPTER 164 OF THE REVISED GENERAL ORDINANCES OF THE BOROUGH OF RIVERDALE AND REVISING THE FEES FOR WATER AND SEWER SERVICE

BE IT ORDAINED by the Mayor and Council of the Borough of Riverdale, in the County of Morris and State of New Jersey, as follows:

Section 1. Chapter 164, Section 164-10 entitled "Charges for service connections; materials," Subsection A, shall be amended to read in its entirety as follows:

- A. Each applicant for a service connection to the water system of the Borough of Riverdale shall pay the current connection charges at the time the application is made.

Section 2. Chapter 164, Section 164-19 entitled "Rents, rates and charges," Subsection A (2), shall be amended to read in its entirety as follows:

- (2) The fixed charge for all nonresidential meters shall be based on meter size and is established as follows:

Meter Size (inches)	Fixed Annual Rate
1 ½ and 2	\$400
3 and 4	\$1,232
6	\$1,760
8	\$2,464
12	\$3,520

Section 3. If any section or provision of this Ordinance shall be held invalid in any Court of competent jurisdiction, the same shall not affect the other sections or provisions of this Ordinance, except so far as the section or provision so declared invalid shall be inseparable from the remainder or any portion thereof.

Section 4. All Ordinances or parts of Ordinances which are inconsistent herewith are hereby repealed to the extent of such inconsistency.

Section 5. This Ordinance shall take effect immediately after final passage and publication in the manner provided by law.
