ORDINANCE NO. 06-2015

ORDINANCE AMENDING CHAPTER 135 OF THE REVISED GENERAL ORDINANCES OF THE BOROUGH OF RIVERDALE AND ESTABLISHING FEES FOR CLASSES AND PRIVATE PROGRAMS AT THE SENIOR COMMUNITY CENTER AND THE GLENBURN ESTATE

BE IT ORDAINED by the Mayor and Council of the Borough of Riverdale, in the County of Morris and State of New Jersey, as follows:

Section 1. Chapter 135 of the Revised General Ordinances of the Borough of Riverdale entitled "User fee for privately run classes or programs" shall be amended to read in its entirety as follows:

§ 135-4. User fee for privately run classes or programs.

There shall be a user fee at the Senior Community Center and Glenburn Estate run by a private group, organization, or individual. This fee shall not apply to any Borough-sponsored classes or events and shall be paid by the private group, organization, or individual sponsoring the event. The fee per date must be paid when the reservation is made. The \$1.00 per person per date fee shall be paid by the end of the month.

Community Center

Senior Room and Meeting Room \$15 per date plus \$1 per person

Lower Level

Monday-Friday before 5 PM \$15 per date plus \$1 per person
Weekends – before 10 AM \$15 per date plus \$1 per person
Monday-Friday after 5 PM \$25 per date plus \$1 per person

Main Floor

Monday-Friday before 5 PM \$20 per date plus \$1 per person
Monday-Friday After 5 PM \$25 per date plus \$1 per person

Glenburn

Main Room \$25 per date plus \$1 per person
(No exercise classes permitted)
Barn/Pavilion \$25 per date plus \$1 per person

Section 2. If any section or provision of this Ordinance shall be held invalid in any Court of competent jurisdiction, the same shall not affect the other sections or provisions of this Ordinance, except so far as the section or provision so declared invalid shall be inseparable from the remainder or any portion thereof.

Section 3. All Ordinances or parts of Ordinances which are inconsistent herewith are hereby repealed to the extent of such inconsistency.

Section 4. This Ordinance shall take effect immediately after final passage and publication in the manner provided by law.
