RESOLUTION AUTHORIZING THE REFUND OF TAXES TO DOUGLAS FRITSCH PURSUANT TO N.J.S.A. 54:4-3.32

WHEREAS, Douglas Fritsch, 28 Parkway, Riverdale, New Jersey was certified by the Department of Veterans Affairs as 100% disabled as of March 23, 2016 in accordance with the Veterans Affairs Rating Schedule; and

WHEREAS, Douglas Fritsch applied on August 8th, 2016 for a tax exemption on his home known as Block 21, Lot 13 pursuant to N.J.S.A. 54:4-3.30; and

WHEREAS, pursuant to N.J.S.A. 54:4-4.43, the Governing Body of a municipality, by appropriate Resolution may return all taxes collected on property which would have been exempt had a proper claim in writing been made therefore; and

WHEREAS, the Governing Body will cancel the remaining taxes for 2016 in the amount of \$3,363.53 and refund taxes paid from January 1, 2016 to March 23, 2016 in the amount of \$1,173.94 and

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Borough of Riverdale, in the County of Morris and State of New Jersey that the Tax Collector is hereby directed to refund an amount of \$1,173.94 to Douglas Fritsch representing a refund of taxes paid on property known as Block 21, Lot 13, and also known as 28 Parkway.

Mr. Douglas Fritsch has been approved for the 100% Disabled Veteran for the 2016 tax year. Under N.J.S.A. 54:4-3:30 et seq., the property identified as Block 21 Lot 13 in Riverdale Borough is 100% exempt from property taxes starting March 23, 2016. Under this statute the council is required and has the authority to cancel all taxes due for the current year. The property will be included in on the exempt property tax list starting in 2017.
