TITLE:

APPROVING A TOW OPERATOR’S LICENSE TO MALANGA’S AUTOMOTIVE, INC. IN ACCORDANCE WITH THE PROVISIONS OF CHAPTER 154 OF CODE OF THE BOROUGH OF RIVERDALE

WHEREAS, Chapter 154 of the Borough Ordinances titled “Towers and Wreckers” sets forth the means and manner by which tow operators shall be qualified to conduct business as licensees (known as “Towing Operators”) within the Borough; and

WHEREAS, Malanga’s Automotive, Inc. has submitted an application pursuant to section 154-2 of the Borough Ordinances to be designated as a Towing Operator; and

WHEREAS, the Chief of Police has determined that Malanga’s Automotive, Inc. has fulfilled the application requirements set forth in Chapter 154-2 and as further set forth in Chapter 154; and

WHEREAS, the Chief of Police has recommended to the Mayor and Borough Council that Malanga’s Automotive, Inc. be designated as a Towing Operator.

NOW, THEREFORE, BE IT RESOLVED, by the Borough Council of the Borough of Riverdale, County of Morris, State of New Jersey, as follows:

That the Mayor and Borough Council do hereby authorize Malanga’s Automotive, Inc. as a Towing Operator pursuant to Borough Ordinance 154-2, effective upon passage of this Resolution and ending on December 31, 2016.

BE IT FURTHER RESOLVED, that the Mayor and the Borough Attorney and all municipal officials are hereby authorized to take such action as is necessary to implement the purposes of the resolution, that a copy of the resolution certified by the Borough Clerk.

NOTE: The following must accompany the application for license:

1. Certification of liability and property damage insurance for said wrecker in the policy limits of no less than one million/three million dollars (\$1,000,000/\$3,000,000) per occurrence. The certificate of insurance shall be issued by a company certified to do business in the State of New Jersey. Each policy so required must contain an endorsement providing for a thirty-day notice of cancellation, stating that the Borough of Riverdale and the licensee shall receive thirty (30) days notice of cancellation by certified mail.
2. The application for the license shall be accompanied by a certificate for full Comprehensive Automobile Liability Insurance, including hired and non owned Auto Coverage.
3. The application shall be accompanied by a certificate for full garage keepers legal liability coverage, including fire, theft, collision and comprehensive, including vandalism and malicious mischief.
4. The Borough of Riverdale must be named as an additional insured under the liability portion of the insurance coverage.
5. The towing-wrecking firm must establish a hold harmless indemnification agreement in favor of the Borough of Riverdale for all liabilities (both legal and equitable) arising out of the performance of the contract.
6. The fee for the license issued under this chapter shall be \$150.00 per year paid on receipt of said license. The license shall remain valid from January 1 to December 31 of each year or part thereof.


